### FORM CHANGES TO ALLOW AFFIRMATIONS IN LIEU OF AFFIDAVITS

Legislation was recently signed that takes effect January 1, 2024, that removes the notarization requirement and allows affirmations to have the same force and effect as affidavits.

To reflect this legislation, the Board has updated several forms that previously required notarized affidavits to remove the notarization requirement and allow affirmations under the penalties of perjury under the laws of New York, with the same force and effect as an affidavit.

## BOARD TO INDEX EVERY COMPLETE CASE BY MID-2024

In order to provide clarity and promote efficient resolution of workers' compensation claims, the Board plans to begin indexing every complete case by mid-2024. This means that every case with an Employee Claim (Form C-3) or First Report of Injury (FROI) and a medical report of treatment will be indexed by the Board. Following indexing, any denial of the claim must be filed with the Board within 25 days of the date of indexing or defenses listed in Workers' Compensation Law Section 25(2)(b) will be barred.

## AFFIRMATION OF A HEALTH CARE PRACTITIONER BILL SIGNED INTO NYS LAW

The NYSCA Legislative Committee is pleased to share a legislative update regarding the passage of a bill (S2997/A6065) that will create a level playing field for all health care providers who are assisting a patient in a lawsuit. Chapter 585 of the Laws of 2023 amend New York's Civil Practice Law and Rules to extend provisions that allow for the submission of health care statements under the penalty of perjury instead of requiring a notarized statement from the health care provider.

## Regenerative Medicine and Non-Surgical Orthopedics

The emerging field of regenerative medicine is focused on maximizing the bodies inherent healing process, to improve tissue quality and even slow down the progression of arthritis. Musculoskeletal injuries both acute and chronic plague people on a daily basis. Advances in ultrasound technology have made it possible to directly visualize pathology with a complete dynamic and diagnostic in office evaluation. Once identified, this pathology can be treated with the best personalized regenerative option. Here we will discuss three of these customizable regenerative treatment options: Prolotherapy, PRP (platelet rich plasma), and Stem Cells. Prolotherapy, is a regenerative technique which utilizes a dextrose solution and has been around for centuries. Historically it was used for patients with ligamentous laxity to improve the stability of their joints, but can also be used to strengthen injured ligaments/tendons. Additionally, because prolotherapy is created from dextrose, it is not contraindicated in patients on blood thinners or who have a history of cancer. PRP, platelet rich plasma, is a popular regenerative option, which can be used for a range of musculoskeletal pathology. PRP is created by drawing a patient's blood and centrifuging it down to just the platelet rich plasma portion. But beware: Not all PRP is created equal. Because there is innate variation in patients' platelet count, and there is no defined quantity of blood drawn during the PRP process, it is important that the clinician creating the PRP is experienced. There are nuances of treating different tissue pathology while accounting for the chronicity of the injury. How does it work? The platelet portion of the blood contains alpha granules which release a variety of growth factors. These growth factors then work to reestablish homeostasis, allowing the tissue to restore its innate ability to heal itself. Stem cells have been another hot topic in regenerative medicine. There are only 2 places to obtain active stem cell on the adult human; bone marrow and adipose. Bone marrow is harvested from the bone and is therefore a more invasive regenerative/orthobiologic option. Attempts have been made to try and store/preserve these stem cells, however on further testing they die during the preservation process. For this reason, they must be harvested and utilized within the same visit. Bone marrow aspirate offers a more diverse cellular arrangement, creating a more homeostatic environment for healing. It can be used in more advanced pathology such as cartilage lesions or larger tendon tears. The above regenerative options coupled with advanced ultrasound technology, can provide precisely guided in office treatment. For more information about this topic, visit: drdegiorgio.com




